Camping with Pets

- 1. Pets must be on a leash at all times when in the campground.
- 2. You must clean up after your pet.
- 3. Pets should not be left unattended at the campsite.
- 4. Pets must be kept on your site, the roadway, or the dog walk area. They should never be in another campsite.

Pets are welcome at Wright's Orchard Station Campground. However, if they frighten or disturb other campers, or if you do not clean up after your pets, they can not be permitted to staty with us. If you know that your pet makes excessive noise or acts ferocious, please tell us at the time of registration. We would like to avoid difficult situations. If you are given a site and your pet disturbs other campers or, if it is documented you are not cleaning up after your pet, you will be asked to leave the campground.

Visitor Policy

Any person who will be visiting you in our campground during your stay must report to the campground office immediately. Parking for additional cars is limited, so they will be instructed where to park. If you anticipate guests please tell us when you are registering.

Pavilion

The pavilion is for our campers use. If you would like to use this facility during your stay please check with the office to reserve it and to pay any fees for use.

Rules

- 1. Quiet time is 11:00 PM to 8:00 AM. No loud music or noise during this time.
- 2. Check-out time is 12:00 PM. If you need to stay later please check with the office to see if the site is available. There may be a late departure charge.
- 3. Only 1 vehicle per campsite. You must check with the office if you require additional parking.
- 4. Only 1 camping unit per site.
- 5. No washing dishes, pans, etc. in the bathroom sinks. Please use the tub in the laundry for this purpose.
- 6. Large mats are not permitted on grassy areas. They kill the grass.
- 7. Fires are permitted in fire rings only. Fires must be kept small and as smokefree as possible. Fires must be attended at all times. Do not burn trash. Fires must be extinguished by 11:00PM. Do not move the fire ring.
- 8. Do not move the picnic table from the site. Please return it to the original position when you leave if you have moved it on the site.
- 9. No washing of vehicles in the campground.
- 10. Garbage and trash are to be deposited in the dumpster at the exit from the campground.
- 11. Waste water may not be discharged on the ground state regulation.
- 12. The use of fireworks, firearms or other weapons is not permitted.
- 13. Alcohol is permitted with discretion. It should be kept on your site.
- 14. Parents are responsible for the safety and conduct of their children. Children and teenagers should be on their site after 11:00 PM.
- 15. Living plants, trees, and shrubs are an asset for all; please protect them. Cutting or breaking branches by a camper is prohibited. Please see the office if you need anything trimmed.
